Please read the following carefully and sign below:

- We ask that you arrive and conclude your party as scheduled. Deviations from these times will result in additional charges.
- Guests will only be allowed to use the equipment provided to them by a staff member.
- You are in charge of your guests' behavior. You will be responsible for any damage that occurs as a result of your party.
- A YMCA chaperone will lead all activities. Party participants must take direction from the chaperone in charge.
- The YMCA reserves the right to cancel group activities if behavior is deemed inappropriate and/or presents a potential risk to another participant or YMCA staff.
- Any party that does not respond to the YMCA rules or directives may be asked to leave the building and no refund will be given for failure to adhere to requirements.

Pool Party:

- Swimsuits are required.
- All swimmers with shoulder length or longer hair are required to tie hair back.
- All parties must swim for the first hour and eat for the remaining 45 minutes.
- Bathing Suits are required
- All non-swimmers **MUST** stay in the shallow end of the pool (swim test REQUIRED).
- Flips, spins, jumps and diving of any kind are forbidden.
- Floats and recreational inflatable devices are not permitted.
- If lifeguard blows the whistle, all swimmers must stop what they are doing and listen to the lifeguard for instructions.
- If a swimmer has an accident and vomits or emits fecal matter into the pool, the pool will be closed immediately. All aquatic programming **MUST** be cancelled until foreign material is removed and the pool water is tested. **NO** credits or refunds will be issued if a member of the party is the cause of such an incident. This will also result in shortening your party time.
